**Additional Conditional to be made part of the general conditions of contract**

- 1- If any who so ever is found actively associated with mafia and unsocial elements or engaged in orgnized crime or is a mafia of mafioso is disqualified from bidding.
- 2- Even if it comes to knowledge after aword of a contract that the contractor is associated with mafia and unsocial element or engaged in organized crime or is a mafia of mafiso, the contract will be cancelled after serving a show cause notice and if the cantractor is found repeating the same, then the proceeding of black listing him shal also initiated.
- 3- If it is found that the contractor or the bidder has threatened the other bidder or prevented them from bidding the tender/contract will be cancelled.
- 4- Any advocate registerd in state bar council will not be authorized for bidding. if it comes in knowledge that the contractor is a state bar council registerd advocate, the contract will be cancelled after having been satisfied of this fact.
